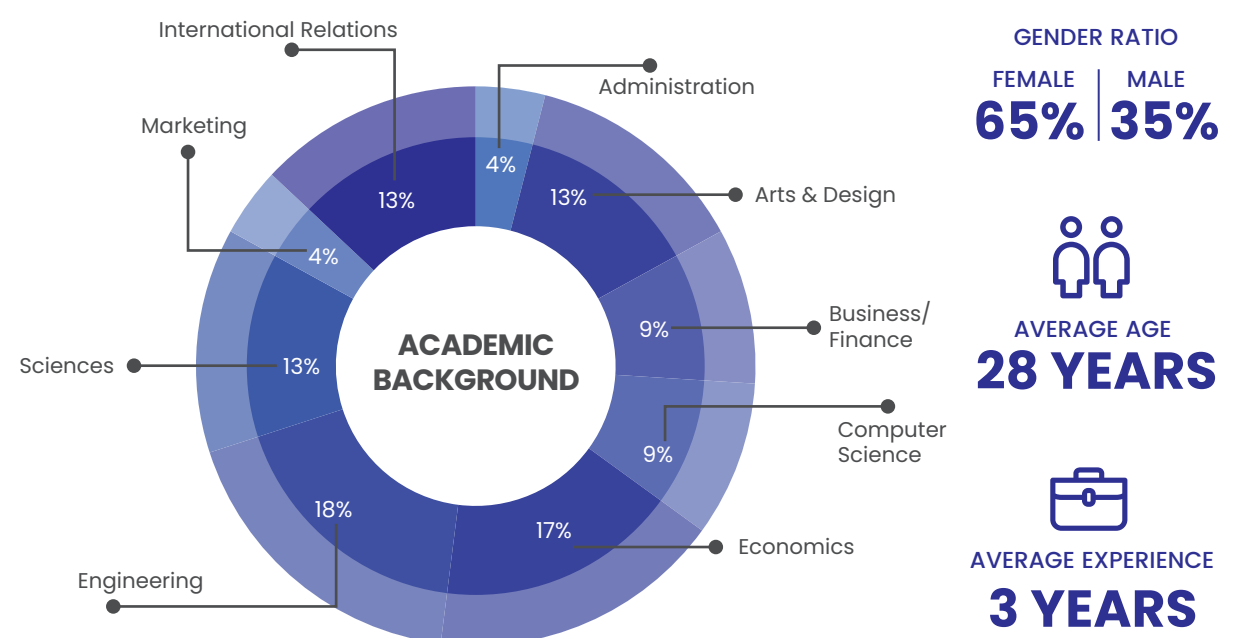

## MS BUSINESS AND PUBLIC POLICY

The MS in Business and Public Policy (BPP) is a diverse 1.5-year weekend programme that will equip you with the knowledge, understanding, and experience related to the management of modern public sector organisations. It will expose you to innovative business practices used in designing policy for the advancement of economic activity. Special emphasis is given to how institutions of trade, commerce, and government mutually shape the agenda for economic policy.

The programme aims to provide business understanding tied to leadership-based knowledge in public policy to open up careers in:

- Public sector spaces
- Chambers of commerce and industry
- Consulting firms
- Policy communication
- Government relation divisions within multinational organisations
- Non-governmental and civil society organisations

## PROGRAMME STRUCTURE

The MS Business and Public Policy weekend programme requires 1.5 years to complete 33 credit hours. Participants may be required to attend some class sessions on selected weekdays. Participants of this programme will undertake substantial academic work with continuous peer and faculty interaction between these sessions.
